<p>PUBLIC SERVICES <u>Neighborhood Revitalization</u> <i>Funding Source:</i> Community Development Block Grant <i>Summary of Grant Program:</i> Services, programs, or activities carried out by neighborhood organizations that promote safety, prevent blight, and revitalize neighborhoods in low-income areas. <p><u>PUBLIC SERVICES</u> <u>New Starts</u> <i>Funding Source:</i> Community Development Block Grant <i>Summary of Grant Program:</i> This priority encourages newly formed start up agencies or inexperienced agencies an opportunity to compete for funding. Proposals are limited to Youth Services, Childcare, and Enrichment Programs for Youth, Support Services to Persons with Disabilities and Seniors and Neighborhood Revitalization Services. <i>Dollar amount:</i> \$15,000 cap <i>Eligible Applicants:</i> Non-profit corporations, schools, and charter schools. Eligible activities include acquisition, new construction or rehabilitation of public facilities, i.e., senior, youth or childcare center, domestic violence shelter, neighborhood facilities, or Americans With Disabilities Act (ADA) modification projects. Eligible activities include acquisition, new construction or rehabilitation of public facilities, i.e., senior, youth or childcare center, domestic violence shelter, neighborhood facilities, or Americans With Disabilities Act (ADA) modification projects. NEIGHBORHOOD REVITALIZATION - Open Application

Funding Source: Community Development Block Grant
Summary of Grant Program: Available to non-profit corporations providing comprehensive coordinated neighborhood revitalization efforts with the participation of neighborhood organizations.

Eligible activities include:

- Major and minor housing rehab;
- Acquisition and rehabilitation, conversion of vacant/tenant-occupied properties, and homebuyer assistance (single-family owner-occupied properties);

Dollar amount: No set annual cap, dependent on City's annual allocation.

Eligible Applicants: Non-profit corporations in partnership with neighborhood organizations.

Housing Counseling Open Application Program

Funding Source: Community Development Block Grant
Summary of Grant Program: Housing counseling services that increase the awareness of homeownership opportunities, improve the access of low and moderate income households to sources of mortgage credit, and provide predatory lending housing counseling.

Dollar amount: No set annual cap, dependent on City's annual allocation.

Eligible Applicants: Non-profit corporations in partnership with neighborhood organizations.

Neighborhood Infrastructure Program

Funding Source: Community Development Block Grant
Summary of Grant Program: Projects sponsored by City of Phoenix departments in partnership with neighborhood associations to improve streets, sewers, drainage, and other infrastructure items in the Enterprise Community, Neighborhood Initiative Areas, Redevelopment Areas and other low/moderate income areas. Projects must meet federal requirements to benefit primarily low-and-moderate income persons, or prevent or eliminate blight.

Dollar amount: No cap, match is required.

Eligible Applicants: Neighborhood Associations or non-profit organizations in partnership with a City of Phoenix Department.

Neighborhood Enhancement - Program

Funding Source: Community Development Block Grant
Summary of Grant Program: Projects sponsored by city departments in partnership with neighborhood associations that address neighborhood needs. Park amenities, playgrounds, neighborhood streetscaping, landscaping, gateways, security improvements, physical improvements related to neighborhood traffic mitigation, street/alley closures, etc. Projects must meet federal requirements to benefit primarily low-and-moderate income persons, or prevent or eliminate blight.

Dollar amount: \$100,000 cap

Eligible Applicants: Neighborhood Associations or non-profit organizations in partnership with a City of Phoenix Department

<p><u>Homeless Services - Request for Proposal</u> Fund Sources: Community Development Block Grant and Emergency Shelter Grants Summary of Grant Program:</p> <ul style="list-style-type: none"> • Emergency Shelter- Operations: Maintenance, operation, insurance, utilities and furnishings for emergency shelter programs that provide immediate shelter for up to 120 days to persons who are homeless. Grants must result in job creation and/or retention for low-income individuals. <p><u>Expansion Assistance and Development Program (EXPAND)</u> Funding Source: Community Development Block Grant Summary of Grant Program: The EXPAND Program assists Phoenix businesses in obtaining loans from eligible local financial institutions. EXPAND provides additional collateral, up to 50 percent of a loan amount in some cases. The amount of the collateral enhancement can range as high as \$150,000. There is no ceiling on the loan amount. Loans can be for virtually any legitimate business purpose. Jobs creation or jobs preservation is an essential element of any request for EXPAND assistance.
